## RULES AND ENTRY INFORMATION

1. Sale entries DUE NOVEMBER 22, 2021. Mail to M3 Marketing.
  - A. All consignors shall be in good standings with the American Angus Association.
  - B. All entries must be registered with the American Angus Association.
2. All cattle sell under the sale terms and conditions of the American Angus Association.
3. REGISTRATION AND OWNERSHIP. Consignor must own all entries at the time of entry.
4. TATTOOS. Tattoos will be verified at sale site and must be correct with AAA registration papers. Please check tattoos before entries are made. Tattoos and OVC tattoos must be legible!

### SALE EXPENSE

1. All animals (BULL, HEIFER, PICKS OR GENETIC LOTS) will have an entry fee of one hundred dollars (\$100) US per lot. It will be put towards prorated sale expenses. It is non-refundable.
2. The sale management, auctioneer and the Colorado Angus Association will charge a total of 8% plus prorated sale expenses less entry fees.

### HEALTH REQUIREMENTS

1. BRUCELLOSIS – FEMALES AND BULLS
  - A. Official Calfhood Vaccinated (OCV) with a legible vaccination tattoo.
  - B. Females 24 months of age and over must test negative within 30 days prior to sale date or be from a certified free herd.
  - C. Bulls six months of age and over must test negative within 30 days prior to sale date or be from a USDA certified free herd.
2. TUBERCULOSIS – All breeding animals must be tested and negative within 60 days prior to sale date or be from a USDA accredited herd. If from a USDA accredited herd, list the last whole herd test date. If the animals are coming from Michigan, please visit our website at [www.colorado.gov/aganimals](http://www.colorado.gov/aganimals) or call the Colorado State Veterinarian's office at (303) 869-9130 for complete testing details.
3. BOVINE VIRAL DIARRHEA (BVD) – Must be tested negative for BVD persistently infected (PI) status PRIOR to arrival at NWSS. Those without a documented negative test will not be allowed on the grounds. Pooled samples are accepted so long as individual animal identification is maintained and documented. One negative test per animal is sufficient per lifetime. Acceptable tests include immunohistochemistry(IHC), antigen-capture ELISA (ac-ELISA), polymerase chain reaction (PCR) and virus isolation (VI). Please note: BVD serology or titers are not accepted.

4. **SCABIES** – All animals must have been officially treated for Scabies by the following: treated with an Ivermectin or Ivermectin-like product(s) at required dose, according to label directions, between 1 and 10 days prior to arrival on NWSS grounds. If sold, some states of destination may require additional treatments. NWSS veterinarian(s) will address if required.
5. **TRICHOMONIASIS** – All sale bulls 12 months of age or older shall have a negative individual PCR T. fetus test within 30 days prior to entry to the NWSS. No female contact after negative trich test.
6. **ANAPLASMOSIS AND BLUE TONGUE** – A test is optional within 30 days of sale date, as animals may sell to some eastern states that require a negative test for either or both diseases.
7. Individual health certificates **\*\*3 copies each\*\*** are required for each animal or lot in the sale.
8. All cattle must be ready for interstate travel. We suggest if you are interested in sending cattle to other countries like Canada have the proper test done to allow sale cattle to be exportable.
9. **PLEASE HAVE YOUR VET CONTACT THE COLORADO STATE VETERINARIAN FOR COMPLETE HEALTH PAPER REQUIREMENTS REQUIRED FROM YOUR STATE.**

## BRAND REQUIREMENTS

1. All exhibitors coming from mandatory brand inspection states must have a current brand inspection certificate. The original copy of the inspection certificate must be turned in with the health certificate. All animals found to be improperly shipped will be held until released by the state of origin.
2. All out of state exhibitors coming into Colorado for the National Western from non-mandatory brand inspection states must have a legal bill of sale as proof of title accompanying the livestock to and from the National Western Stock Show for exhibition and sale.

## DEADLINE

1. Pedigree information, entry fees, photos & footnotes must be to sale management by Nov. 22, 2021
2. Please make sure quality pictures and videos are taken. We expect a strong online presence through CCI.Live and a quality video will help tremendously for those bidding off-site. This will be a necessity for Donors or other special lots that cannot be at the sale site for extenuating circumstances.
3. LATE FEES – ENTRIES RECEIVED AFTER THE NOVEMBER 22, 2021 DEADLINE WILL BE CHARGED AN ADDITIONAL \$75 PER HEAD.
